Thank you for submitting your Contribution for publication. A. RIGHTS GRANTED

1. The Contributor hereby grants to Ernst & Sohn for the duration of the statutory term of copyright protection, the non-exclusive rights comprised in the Contribution including but not limited to the right to publish, republish, transmit, sell, distribute, store and process in electronic media of any kind, include in document delivery services and otherwise use the Contribution in whole or in part in electronic and print editions of the Journal and in derivative works throughout the world, in all languages and in all media of expression now known or later developed, and to license or permit others to do so.
2. Reproduction, posting, transmission or other distribution or use of the final Contribution in whole or in part in any medium by the Contributor as permitted by this Agreement requires a citation to the Journal and an appropriate credit to Ernst & Sohn as Publisher, suitable in form and content as follows: (Title of Article, Author, Journal Title and Volume/Issue Copyright © [year] copyright owner as specified in the Journal).
